A Money Management Proposal for Bodhi Farm

What is a budget

A budget is a plan.

Budgeteers sit down and decide what income and what expenses they can reasonably expect to encounter in the next year. The budget is thus formed and those who are interested can see how the farm is performing against the budget or plan and make adjustments to either the plan (our expectations) or the expenditure and income (our behaviours).

The advantage of these budgets and the process of creating them is that for a small investment in planning we can all see how we are going against the plan and all contribute to keeping to the plan, rather than leaving it to the treasury group and then complaining they don't do it the right way or well enough. We get to take the responsibility as well as the decisions.

Budgets and budget reports are not panaceas for financial troubles but they do provide information about adherence to the plan. Thus a budget is really only effective if it is well planned and if the farm is able to adjust it's behaviour in response to information from it. In the past we haven't really budgeted in the true sense, though Denise has provided a very close approximate to it. What we did was to set savings targets and "quarantine" certain sums of money. This process doesn't really take into account the situations where we would overspend (or under achieve in income) in some category, which would put pressure on the quarantined amounts.

Some new names

In a good budget, ALL expected expenses are identified and planned for. This should include all capital costs such as roads, water etc as well as a component for contingency. Thus I think our budget and our language should include *CONTINGENCY* which is an amount of money set aside for the unplanned and/or usual expenses such as a new dam or a new set of solar panels or whatever. We would agree in advance how much of our income was to be quarantined for contingency and track that through our budget reports. We would only spend from the contingency after agreement from a farm meeting.

In addition, a credit budget would plan that in any given year we would *Spend-Less-Than-We-Earn*. In other words the budget should be framed so that the projected income exceeds the projected expenditure by an agreed amount. If we are all good boys and girls and stick to the budget we will have excess at the end of the year and we will increase our **RESERVES**. In years when we "blow" the budget we will be spending from these reserves and the treasury group will make suggestions such as reducing expenses next year increasing kitty. Or the farm could agree in advance that this year we will have a deficit budget and reduce our reserves.

And we don't need to use the confusing word "Savings".

A suggested process

- 1. Using previous years figures the treasury group frames a draft budget in time for the AGM each year.
- 2. That a budget meeting be held at the AGM each year to discuss and alter this draft budget but at the end of the AGM we have an agreed budget for the next 12 months.
- 3. This budget should include an income component of *CONTINGENCY*, the farm to agree on this amount each year, bearing in mind the current size of the contingency income carried forward from previous years.
- That the quarterly budget reports be discussed at a farm meeting and alterations to the budget or kitty be agreed if we are losing or have lost contact with the budget and/or reality.
- That agreement be reached at the AGM to transfer any excessive *RESERVES* to CONTINGENCY.
- 6. The farm will from time to time set or adjust the size of the RESERVE.

The role of the treasurer

The treasurer will

- Form the draft budget
- Convene and participate in the budget planning meeting at the AGM
- Enter the final budget into the system
- Enter all data into the system
- Pay bills
- Transfer money between accounts to maximise interest income and to manage cash flow.
- Provide quarterly budget reports and make recommendations for change to the budget or kitty.
- Provide exception alerts at a farm meeting when the budget seems under threat during and threat.
- Harass everyone to pay his or her kitty.
