CONCLUSION

The right wing will find it easier to maintain preferences than the centre and teft wing. The left wing will have to battle for preferences and avoid exhausted votes The right wing could get 4 candidates (maybe 5)

With Tucker as Mayor this would give 5 votes plus the mayor's casting vote and the right wing wins

Tucker is highly likely to become mayor in a scenario where Wilson and Barham refuse to preference each other.

It is only necessary to vote for one candidate as mayor and therefore preferences must be used
